<u>Justification</u>: (state briefly why legislative action is requested)

The Department of Mental Health requests permission to enter into a contract in 2022 with Catholic Charities for the provision of peer engagement and open access treatment services to Albany County citizens with substance abuse and narcotic addiction related issues. NYS Office of Addiction Services and Supports (OASAS) shall provide pass through funding to Catholic Charities through Albany County Department of Mental Health in the amount of \$161,607. This appropriation is anticipated in the 2022 budget. There is no County share associated with this contract.
