Justification: (state briefly why legislative action is requested)

The Public Defender's Office is seeking to accept grant funds from the NYS Division of Criminal Justice Services (DCJS) in the amount of \$42,738 to administer the Aid to Defense Program. The Aid to Defense Program supports enhanced defense services designed to expedite the processing of serious and violent felony cases through the courts. This is a recurring grant, covering April 1,2023 to March 31, 2024, which the Public Defender's Office has received for the past several years, is a direct award based on a DCJS formula, and there is no County match.
