AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO AND AN AGREEMENT WITH THE NEW YORK STATE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES REGARDING THE COMBINED 2025 AND 2026 PUBLIC SAFETY ANSWERING POINT OPERATIONS GRANT PROGRAM AND AMENDING THE 2026 SHERIFF'S OFFICE BUDGET

WHEREAS, The Albany County Sheriff has requested authorization to submit a grant application to and enter into an agreement with the New York State Division of Homeland Security and Emergency Services regarding the Combined FY 2025 and 2026 Public Safety Answering Points Operations Grant Program in the amount of \$456,200 for the term commencing January 1, 2026 and ending December 31, 2028, and

WHEREAS, The Sheriff has indicated that this funding will be used to assist with the costs involved in maintaining Albany County's multi-jurisdictional Public Safety Answering Points Operations, and

WHEREAS, The Sheriff has also requested a budget amendment to incorporate this funding into the 2026 Sheriff's Office Budget, now, therefore, be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to submit an application to and enter into an agreement with the New York State Division of Homeland Security and Emergency Services regarding the Combined FY 2025 and 2026 Public Safety Answering Points Operations Grant Program in the amount of \$456,200 for the term commencing January 1, 2026 and ending December 31, 2028, and, be it further
