**AUTHORIZING AN AGREEMENT WITH BETTE & CRING, LLC
REGARDING THE CONSTRUCTION OF CR9 (BRADT HOLLOW ROAD)
OVER THE FOX CREEK BRIDGE REHABILITATION PROJECT IN THE
TOWN OF BERNE**

By Public Works Committee:

WHEREAS, The Commissioner of the Department of Public Works has requested authorization to enter into an agreement with Bette & Cring, LLC regarding the construction of CR9 (Bradt Hollow Road) Over the Fox Creek Bridge Rehabilitation Project in the Town of Berne, and

WHEREAS, The Commissioner indicated that construction services for the project include the complete removal of the existing superstructure and full depth reconstruction and paving of approximately 415 linear feet of roadway, installation of new bridge and highway railing, placement of stone fill for scour protection, site restoration, and other miscellaneous items, and

WHEREAS, The Department of Public Works, through the County Purchasing Agent, issued a request for bids and on March 30, 2017 ten bids were received pertaining to the project, and

WHEREAS, The Department of Public Works engineering staff along with consultants Barton & Loguidice D.P.C. reviewed said bids and recommended awarding the contract to Bette & Cring, LLC as the lowest responsible bidder, now, therefore be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into an agreement with Bette & Cring, LLC, 22 Century Hill Dr., Suite 201, Latham, New York 12110 in an amount not to exceed \$1,078,790 regarding the construction of CR9 (Bradt Hollow Road) Over the Fox Creek Bridge Rehabilitation Project in the Town of Berne, and, it further

RESOLVED, That the County Attorney is authorized to approve said agreement as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.

AMENDING RESOLUTION NO. 175 FOR 2017 REGARDING A
SUPPLEMENTAL AGREEMENT WITH BETTE & CRING, LLC FOR
CONSTRUCTION SERVICES FOR CR9 (BRADT HOLLOW ROAD) OVER
FOX CREEK PROJECT

By Public Works Committee:

WHEREAS, By Resolution No. 175 for 2017, this Honorable Body authorized an agreement with Bette & Cring, LLC, regarding construction services for the CR9 (Bradt Hollow Road) Over the Fox Creek Bridge Rehabilitation Project ("The Project") in the Town of Berne in an amount not to exceed \$1,078,790, and

WHEREAS, The Project is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 80% Federal funds and 20% non-federal funds for permanent repair work, and

WHEREAS, After completion of the Project asphalt settlement on CR9 between Dutch Settlement Road and the new approach slab for the bridge was observed, and

WHEREAS, The County engaged a geotechnical engineer who undertook soil borings and monitoring of the settlement and recommended a remedy to the issue that was approved by both the NYS Department of Transportation and the Federal Highway Administration at a proposed cost not to exceed \$1,100,000, now, therefore be it

RESOLVED, By the Albany County Legislature that Resolution No. 175 for 2017 is amended to indicate that the agreement with Bette & Cring, LLC regarding additional construction services to remedy the settling of asphalt on CR9 (Bradt Hollow Road) Over the Fox Creek Bridge Rehabilitation Project in the Town of Berne is in an amount not to exceed \$2,178,790 rather than \$1,078,790, and, be it further

RESOLVED, That the County Attorney is authorized to approve said agreement as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.
