## **Justification**: (state briefly why legislative action is requested)

The Department of General Services requests authorization to enter into an agreement with Gilbane Building Company as Construction Manager for Renovations, Additions and Site Work at the Capital District Juvenile Secure Detention Facility pursuant to RFP#2021-124.

The cost of this service is \$827,581 with a 5% contingency of \$41,419 for a not to exceed total of \$869,000.

All cost of these services will be covered under bond number HHW0 pursuant to Res. No. 570 of 2018 adopted December 3, 2018.

The term of this contract will commence upon signing and continue until the project is completed and signed off by the Department of General Services. Projected term is January 1, 2022 through December 31, 2024.
