In coordination with local departments, the Sheriff's Office Fire Coordinator and the County Legislature, several high priority and high urgency needs for local volunteer fire departments to ensure their personnel are well prepared for their duties as well as assist in recruitment, which continues to be a major challenge. The Colonie, Guilderland and hilltown departments are in desperate need of financial support to close the gap in combination with local and state funds to complete the upgrades to their training facilities.
