The Albany County Department of Health (ACDOH) is requesting approval of an agreement with the Civil Service Employees Association, Inc., Local 1000, AFSCME, AFL-CIO, Albany County Local 801 (the "Bargaining Unit") on terms and conditions of employment for the period January 1, 2022 through December 31, 2027. Under the terms of the agreement, employees of the bargaining unit will receive a one-time payment of \$3,000 per member, retroactive salary increase of 2% for January 1, 2022 through December 31, 2023 and an annual increase of 3% for the period January 1, 2024 through December 31, 2027. Other terms and conditions of employment were ratified to include an increase in the longevity amount, a Beeper Payment increase from \$3 to \$6 per hour, adding Juneteenth to approved holidays, and continuation of health insurance in retirement for employees that complete 15 years of service. The 2023 ACDOH budget anticipated the increased salaries and additional increases with the Enhanced Pay line.

As a result of these terms and conditions, we are amending salary lines in the 2023 budget to account for the two 2% salary increases and to cover 2023 retroactive pay. We are also amending the longevity line in the budget to account for the increase in longevity. The 2022 retroactive pay and the \$3,000 one-time payment per member will be paid from the Enhanced Pay line directly.
