The Town of Colonie requests \$19,000.00 through Albany County's Improvement Initiative, Resolution No. 448 to upgrade and repair the Lisha Kill Pocket Park located at 44 Amelia Drive, Schenectady NY 12309, in the Town of Colonie. This is a 6.30-acre park that provides recreational opportunities for the local neighborhood. It is comprised of an ADA playground, tennis courts, basketball courts and a large sports field. Over the years, the courts and fencing around the courts has become deteriorated to the point that they can not be used safely. Attached are pictures of the courts and fencing as they appear today.







The objective of our proposed project is to revitalize this park by installing all new fencing and replacing the existing blacktop courts with new blacktop and striping.



The Lisha Kill pocket park serves a large portion of the western part of the Town of Colonie. The Town of Colonie constructed these pocket parks throughout the town enabling the neighborhood residents to walk to the parks for recreational activity. As you can see by the picture of the area on the next page, there are approximately 25 streets within walking distance and many more in the surrounding area. This project will allow these residents the opportunity to have a state-of-the-art facility for tennis and basketball.

As with any Town or Village government, there are limited financial resources available and projects have to be prioritized. The Town of Colonie is committed to bringing our parks back to the conditions that the community expects. We are currently upgrading the parks that we partner with Albany County Parks and Recreation for their summer youth camps (Flag Football, Baseball, Pickleball, Lacrosse) and are also revitalizing the waterfront for the community to once again enjoy. With the cost of doing over just the Basketball and Tennis courts for one small park is well over 50 thousand dollars, we are limited financially to how much can be accomplished each year.

At this time there are no matching funds for this park in 2024. Hopefully this grant can be utilized in a later fiscal year
