The Department of Public Works is requesting the Legislature's approval to enter into a contract with Tracey Road Equipment, Inc., for the purchase of one (1) Hyundai HL940A Wheel Loader (\$173,928.50) and one (1) Hyundai HL960A Wheel Loader (\$213,907.90) using Sourcewell Contract #032119 HCE.

The HL940A Wheel Loader will replace the loader in our Coeymans Division and the HL960A will be assigned to our New Scotland Division. Both pieces of equipment will be used during our snow removal season to load salt/sand and to push back snow on County and State Roads. This equipment is also used for the remainder of the year for loading materials and grading roadways. The HL960A Wheel Loader will also be used for loading the impact crusher machine. These purchases will be made using Extreme Winter Recovery money for a total purchase amount not to exceed \$387,836.40.
