Shaker Place Rehabilitation and Nursing Center respectfully requests approval of the lease agreement for the operation of the Little Sprouts Daycare at Shaker Place. The day care center will be operated initially to serve eighteen (18) month old through five (5) year old children of employees of Albany County with preference given to Shaker Place staff for availability.
