## <u>Justification</u>: (state briefly why legislative action is requested)

The Department of Public Works is requesting the Legislature's adoption of a Resolution to transfer maintenance responsibilities and ownership of a no longer needed portion of the County Highway System and authorization to convey it to the Town of Westerlo as per the Town's request.

The portion of the County Highway System is known as Old CR401. This portion of road is no longer needed for Albany County use since CR401 was realigned many years ago. This portion of the road is also not built to County specifications. It is however built to a Towns specification and safer for a Town to plow with smaller equipment versus the county. The Westerlo Town Board approved a resolution to accept Old CR401 at their meeting on 12/27/23.
