The NYS Office of Victim Services (NYS OVS) is seeking proposals for the Victims of Crime Act (VOCA) Victim and Witness Assistance Grant Program. This grant provides financial support to community based organizations providing direct services to victims of crime. The VOCA Victim and Witness Assistance Grant Program is funded by the Federal Victims of Crime Act of 1984 which supports victim compensation and victim assistance programs. This is a three year grant award with a possible one (1) two year renewal period. This grant provides an expanded opportunity for CVSVC to respond to the challenge of finding new solutions for serving victims of crime, developing innovative and comprehensive ways to meet their complex needs, and for reaching underserved populations.
