DESCRIPTION OF REQUEST: (state briefly why legislative action is requested)

ACDMH recently received approval to purchase two new electric Mobile Offices for the MOTOR Program, funded through a combination of Opioid Settlement and American Rescue Plan Act (ARPA) funding. With these vehicles expected to arrive this spring, ACDMH is now ready to hire staff to expand the program.

These positions include:

- Community Team Leader Base salary: \$65,526
- Peer Advocate (CRPA) II Base salary: \$51,943
- Credentialed Alcoholism and Substance Abuse Counselor (CASAC) II Base salary: \$61,526

Each position will be full-time, working 35 hours per week.

The CASAC II and CRPA II will work in the vans alongside the existing CASAC and Peer positions, bringing additional expertise to the MOTOR Program while also creating a career pathway for substance use counselors and peer support advocates within the department.

The Community Team Leader role, open to either a CASAC or CRPA, will coordinate the MOTOR Program, help staff the vans, and lead community education and outreach initiatives.

The three-year total, inclusive of staffing and fringe, for this staffing initiative is \$966,388.

- Year 3 Total: \$328,677
- Year 4 (Prorated Jan-May): \$141,569
