Legislature's approval of an agreement with the NYS Governor's Traffic Safety Committee to accept funding regarding the Child Passenger Safety Program. Albany County was notified by the NYS Governor's Traffic Safety Committee that we are being awarded \$37,000.00 in funding. The \$37,000.00 is funding for federal fiscal year dating from October 1, 2023 to September 30, 2024. The funding allows the department to purchase \$31,000.00 in car seats and the remaining \$6,000.00 will be used to purchase other items such as tent rental for events, purchase of curriculum and education materials, etc.
