This tenant is current on payments owed and has been an excellent tenant over the years and they would like to continue to lease this suite going forward. They have accepted our offer to extend a credit for any amounts that were paid during the thirteen (13) months when the arena was closed due to the pandemic and we will work with the Albany Count Attorney's office to make sure these provisions are contained within the new renewal lease agreement. During the "closure period which was the span of months (April 2020 - April 2021) caused by the pandemic, Stanley Steamer paid \$7,250, however they did not have the use of Suite # 20 during this time period. Therefore, a credit in the amount of \$7,250 is being applied towards the amounts owed for the use of Suite #20 during the next three-year lease as follows: Year 1 \$43,750, Year 2 \$51,000, Year 3 \$51,000.
