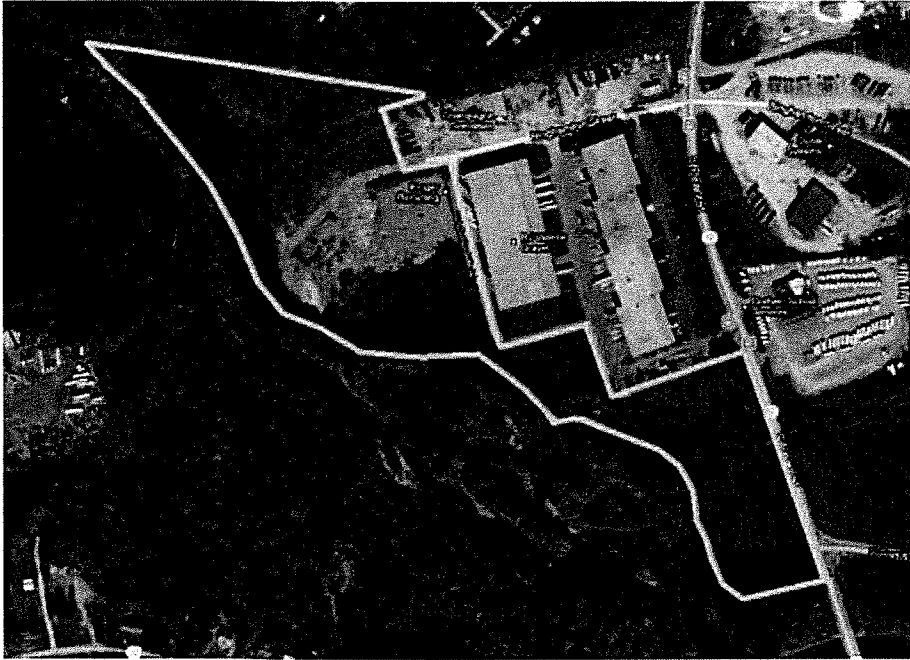

High-rise fire training tower to provide realistic training for a variety of evolutions including:

- Hose Line advancement
- Fire attack
- Ventilation
- Search and rescue
- Laddering and rappelling
- Roof operations
- Firefighter Bail-Out exercises
- Confined space exercises
- High-angle rescue operations
- Elevator Rescues
- Simulated fires in basements 1st, 2nd, 3rd and upper level floors
- Civilian Egress

To Include:

- Props for vertical ventilation
- Hazardous Materials training (including Lithium Ion Battery Ops, Decon procedures)
- Siamese Fire Department connections
- Sprinkler Systems
- Accident victim extrication
- Confined space scenarios
- Rope rescue
- EVOC course

Facility Equipped with:

- 30 Student Classroom
- Offices for Training Staff
- Restrooms / Showers
- Storage for tools and equipment
- Multiple live fire burn areas (multiple floors)
- Hydrants / Drainage *(as opposed to HensCo.)*
