## <u>Justification</u>: (state briefly why legislative action is requested)

The Department of General Services respectfully requests approval of a bond resolution authorizing \$2,403,000 for LED Expansion at the MVP Arena. The expansion will include Install New LED Fascia to run all the way around the bowl. Move the back lit signs up. The fascia lights will increase the effects of the arena in the bowl and increased square footage could help increase revenues from these signs. Existing LED lights would relocate to the concourse for increased revenue. Back lit signs have been proven and long standing source of revenue and should be relocated and not replaced. Scoreboard modification would be replacing power supplies that are failing and cleaning. This project has been included in the 2022 Capital Plan.
