Requesting Legislative Action rescinding the prior authorization to convey the delinquent tax foreclosed property located at 343 First Street (Tax Map No. 65.56-3-61) in the City of Albany per ABL Res No. 506 of 2017 to the Albany County Land Bank Corporation and to instead authorize conveyance of this property to Juan D. Albarracin, 174 Ridge Street, Newark, New Jersey, 07104-113 for the sum of \$20,328.14.

Due to confusion as to ownership of 343 First Street resulting from the Land Bank not have taken title to it from the County as authorized by ABL Res No. 506 of 2017 this property was erroneously deeded by a third party to Mr. Albarracin thereby resulting in a title dispute between himself and the County. To solve this dispute he has offered to pay all delinquent taxes and any out of pocket expenses the County has incurred on 343 First Street in return for a Quitclaim deed to the property from the County to him.

Attached is a suggested draft resolution for this matter reviewed by the Department of Law.

The following will be part of the sale of this property and is requested to be stated in the approval resolution of sale:

Mr. Juan D. Albarracin will pay all delinquent taxes and any out of pocket expenses the County has incurred on 343 First Street in return for a Quitclaim Deed to the property from the County. He will also be responsible for payment of all closing costs and the 2023 Property Tax Bill.
