#### Request to enter into a contractual agreement with the Anderson Center for Autism

The Department for Children, Youth and Families respectfully requests Legislative authorization to enter into a contractual agreement with the Anderson Center for Autism for a youth who is in the County's Care and custody. The term of the contract will be July 1, 2022 through June 2023. The contract will not exceed \$414,471.24, which includes tuition and maintenance costs.

Anderson Center for Autism is a special education program for children with developmental delays. Children residing on the campus are typically placed via the School District, however Albany City School District is not in agreement. This child has been at Albany Medical Center for over 100 days and is in desperate need of a therapeutic program. Anderson School has been the only residential program, in New York and other surrounding States, willing and able to meet this child's needs.

WITNESSETH: The County is authorized by law to contract with approved institutions within the State of New York for the instruction of children with developmental disabilities who are not receiving the benefit of appropriate instruction because County is unable to provide for such education in special classrooms in the public schools due to the unusual type of developmental disability or combination of disabilities, and

WHEREAS, the Private School is an educational institution approved by the Education Department of the State of New York for the education of children with developmental disabilities.

NOW, THEREFORE, the parties mutually agree as follows:

1. The Private School will provide appropriate education for children with developmental disabilities in accordance with the provisions relating to eligibility of schools contained in Part 200 of the Regulations of the Commissioner of Education of the State of New York and **Albany County** law. The identity of such children with disabilities is contained in "Appendix A", attached hereto and made a part hereof.

#### **RESOLUTION NO. 387**

#### AUTHORIZING AGREEMENTS WITH FOSTER CARE PROVIDERS

Introduced: 11/9/20

By Social Services Committee

WHEREAS, The Commissioner of the Department for Children, Youth and Families has recommended that the County enter into two-year agreements with foster care agencies for children whose care has become the responsibility of Albany County, and

WHEREAS, Consideration for the services rendered by the agencies is in the form of a rate established by the New York State Department of Children and Family Services as a maximum per diem reimbursement per child, now, therefore be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into two-year agreements with the agencies set forth in the "Foster Care Agency" list annexed hereto at rates determined by New York State with notice to the County for a term commencing January 1, 2021 and ending December 31, 2022, and, be it further

RESOLVED, That the County Attorney is authorized to approve said agreements as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.
