Dear Chairman Joyce:

The Department for Aging (DFA) requests legislative approval to enter into a new contract with Peter Young Industries, to provide Home Delivered Meals to seniors who reside within Albany County and meet specific criteria as required by Albany County, NYSOFA, and the Albany County Central Assessment Unit. Peter Young Industries will provide Home Delivered Meals to seniors within the following zones; Colonie, Arbor Hill, and Guilderland. The number of meals contracted in this zone area for 2024: **44,448**

Request for Proposal No. 2023-091 issued on July 20, 2023 requesting providers submit a proposal regarding the Home Delivered Meal program. There was a response to the RFP from four (4) providers. The four (4) were evaluated and rated by the department scoring committee using the following criteria:

- Full demonstrated comprehension of the Scope of Services; including but not limited to; Knowledge
 of food safety/sanitation regulations and nutrition standards; Current Dietary Guidelines including
 knowledge and compliance with USDA nutrition standards.
- Prior experience and/or equivalent training with quantity food production and service projects
- Professional qualifications, staffing, equipment, and demonstrated capabilities.
- Total proposed price.

After reviewing the proposals and rating scores the Home Delivered Meal proposals were awarded as follows;

- 1. Life Path (Senior Services of Albany); Awarded \$972,290.00
- 2. Peter Young Industries; Awarded \$441,449.52
- 3. Senior Projects of Ravena; Awarded \$ 263,340.50
- 4. Albany Jewish Community Center; \$52,000.00

Total Awarded to Providers - \$1,729,080.02

The meal delivery shall include regular client monitoring, along with informing the community about the Home Delivered Meal program through education handouts and presentations Peter Young Industries shall be
