The Department of General Services requests Legislative approval of a contract with New York State Unified Court System in the amount of \$709,061, pursuant to Section 1 of the existing contract between the Unified Court System and the County of Albany.

The services that will be provided include custodial services, building maintenance and minor repairs. During this period, all terms and conditions of the original Agreement shall continue to apply. This term will commence on April 1, 2020 through March 31, 2021.
