The Department of Mental Health requests permission to enter into a contract in 2023 with Capital Counseling for the provision of compulsive and problem gambling treatment services to Albany County citizens. NYS Office of Addiction Services and Supports (OASAS) shall provide pass through funding to Capital Counseling through Albany County Department of Mental Health in the amount of \$266,116. This appropriation is anticipated in the 2023 budget. There is no County share associated with this contract.
