The Department of General Services respectfully requests the approval of an amendment to contract 4096 of 2018 to proceed with the Design Development, Construction Documents and Bidding & Construction services for the Renovations, Additions and Site Work at the Capital District Juvenile Secure Detention Facility pursuant to RFP#2018-030.

The costs of this phase is \$662,993 with a contingency allowance of \$33,150 for a total not to exceed \$696,143.

All cost of these services will be covered under bond number HHW0 pursuant to Res. No. 570 of 2018 adopted December 3, 2018.

The term of this contract will commence upon signing and continue until the project is completed and signed off by the Department of General Services. Projected term is January 1, 2022 through December 31, 2024.
