<u>Justification</u>: (state briefly why legislative action is requested)

The Department of General Services requests authorization to exercise the renewal clause of Resolution 435 of 2017 for Family Court cleaning services provided by New York State Industries for the Disabled, Inc. with a projected total of \$146,267. This projected total assumes a prevailing wage increase of 5% beginning July 1, 2021. Under the current OCA agreement the State will reimburse the County for 79% of the total cost.
