#### I. Purpose

The purpose of this Administrative Directive (ADM) is to issue the Rate Year (RY) 2024 Domestic Violence State Aid Rates (DVSARs) for licensed domestic violence (DV) residential programs outside the five boroughs of New York City (Rest of State, ROS). These DVSARs are for the period January 1, 2024, through December 31, 2024. A separate directive is issued for licensed DV residential programs located within the five boroughs of New York City (NYC).

## II. Background

The New York State Office of Children and Family Services (OCFS) issues DVSARs annually to local departments of social services (LDSSs) in an ADM, advising districts of the methodology approved by the New York State Division of the Budget (DOB) for the purchase of services from licensed agencies for providing residential DV services. Rates contained in this ADM must be used by the LDSSs in contracts negotiated with the residential providers of DV services. Issuance of these rates is governed by Social Services Law §131-u and the applicable regulations at 18 New York Codes, Rules and Regulations (NYCRR) Part 408.

## III. Program Implications

The DVSARs promulgated in this ADM have been calculated using the DOB-approved RY 2024 rate methodology for ROS DV residential programs, which is the same methodology used in prior years.

The approved rate methodology for licensed residential DV programs in ROS includes the following features:

- The DV Flat Per Diem Rates for RY 2024 include the following growth adjustment factors:
  - Personal Services (PS)= 3.0%
  - Non-Personal Services (NPS) = 6.5%
  - Food Add-On= 7.7%
- The Food Add-On component of the DVSARs is a negotiated item between the DV residential program agency and the LOSS where the program is located. The Food Add-On Rate is included in the DVSARs when the agency and the LOSS formally request the Food Add-On Rate in writing to OCFS. Thereafter, the Food Add-On Rate is included as part of the DVSAR for the specified program until OCFS is otherwise notified.
- 17-OCFS-ADM-16 indicates that residential DV programs are responsible for the costs of background checks and may not require applicants to pay for them. Applicants include employees, volunteers, consultants, and contractors. DV agencies must continue to track the cost of background checks and include them on line 18, Dues/Licenses/Permits on the OCFS-DV-2562, *Report of Annual Expenditures*, per 18-OCFS-ADM-12.
- Agencies that did not submit the Domestic Violence Standard of Payment {DVSOP} submission for the 2022 reporting period will not receive a new DVSAR for RY 2024. The 2023 rate will remain in effect for those agencies and programs until such time as the submission is completed and submitted to OCFS and an updated rate for RY 2024 is requested.
- OCFS will consider revisions to a rate for the following reasons:
  - The Food Add-On Rate needs to be added to or deleted from the base DVSAR.
  - The DVSAR reflects an incorrect rate for the program size and type.

Agencies have thirty (30) days from the issuance of this ADM to appeal the published rate. All appeals must be made in writing and mailed to:

**IV. Required Action**

The DVSARs noted in Attachments A and C of this ADM must be paid by the LDSSs to licensed DV residential agencies that provided residential DV services and care to eligible victims of DV during the period of January 1, 2024, through December 31, 2024.

**V. Effective Date**

This directive is effective as of January 1, 2024.

- Y Westchester Regional Office

**UR:** The UR column indicates if the DVSAR is under review for the agency. If a "U" is listed in this column, the agency's prior year rate remains in effect until further notice.

**FI:** The FI column indicates if the program has been approved to receive a Food Add-On Rate. An "F" in this column indicates that a Food Add-On Rate is included in the DVSAR.
