<u>Justification</u>: Lease/Maintenance of copiers from 2018 are due to expire August 31, 2022. Requesting for approval to provide lease and maintenance for 36 new copiers for various Albany County Departments. All copiers will be networked for use as printers/copiers/and document scanners. Lease costs and usage charges were calculated using estimated quantities and totals \$186,598.24. We are requesting authorization for a total cost not to exceed \$200,000 to cover usage charges in excess of those estimated, unforeseen costs such as relocation and optional costs of hard drive surrender fee and staples.
