**DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

Albany County’s Department of Management & Budget is requesting authorization to accept funding for NYS Division of Homeland Security and Emergency Services FY2024 State Homeland Security Program (SHSP) and State Law Enforcement Terrorism Prevention Program (SLETPP) grant on behalf of the County Sheriff, Department of Health, and Division of Information Services. The County was awarded a total of \$644,038 in funding: 1) \$516,040 under FY2024 SHSP for the Department of Health (\$340,344.74) and the Division of Information Services (\$175,695.26), and 2) \$128,000 under FY2024 SLETPP for the Sheriff’s Office. The SHSP and SLETPP annual funding opportunities support sustainment of existing capabilities and development of new ones. DOH, DIS and the Sheriff’s Office will budget their grant money into subsequent annual County budgets. State Homeland Security Program and State Law Enforcement Terrorism Prevention Program grants are both 100% federally funded with no County match requirement.
