The program is designed to provide enhanced case management services to Raise the Age population, while incorporating the use of parent advocates and community coaches/credible messengers. These individuals will be members of the community with real life experiences that will be helpful in assisting youth and families navigate the juvenile justice system, all of which will be under the supervision and guidance of a case manager. Service will include mentoring, transportation, skill building, parental support/education, housing assistance and vocational/educational advocacy. Northern Rivers will work closely with the Probation Department responding to each youth's individual needs.
