AUTHORIZING THE DEPARTMENT OF CIVIL SERVICE TO ENTER INTO AGREEMENTS WITH VARIOUS INSTITUTIONS OF HIGHER EDUCATION AND VOCATIONAL TRAINING REGARDING WORK STUDY PROGRAMS

By Personnel Committee:

WHEREAS, The Director of the Department of Civil Service has requested authorization to enter into cooperative agreements with various Capital Region higher educations and vocational institutions regarding internship and work study programs for Albany County, and

WHEREAS, The Director indicated the request will streamline the internship acceptance process, and that in the past the County has lost out on potential candidates because the current approval process takes too much time between offer and start dates, and

WHEREAS, Many Capital Region higher educational and vocational institutions already have a history of partnering with Albany County for these programs on an individual basis, now, therefore, be it

RESOLVED, By the Albany County Legislature, that the County Executive is hereby authorized to enter into agreements with all the higher educational or vocational institutions for work study and/or internship programs with Albany County as follows:
