To whom it may concern,

I am writing to request a Correction to the 2022-2024 Town & County and School Tax on behalf of Matthew Timony whose property is located at 6 Van Wie Ter. aka 013089 51.12-4-3.

January 31, 2013 Matthew A Timony Veteran's exemption was processed and was determined to qualify for a Combat Veteran's exemption which at the time was coded 41131 25%. February 21, 2013 Matthew brought in his Disability Award letter from the Veteran's Administration awarding him a 80% service-connected disability and was reviewed and applied to the file. Upon a conversation with the homeowner regarding his school taxes it was found that his Veteran's Disability exemption was not being applied to his property since submission in 2013. Exemption was applied to RPS 10/29/2024 per RP-553 Correction of Errors.

Attached you will find an executed copy of the RP-556 for each tax bill, a copy of the tax bill, RPS screenshots of incorrect and corrected exemption codes, and a copy of the exemption paperwork. If you need any further information, please let me know.

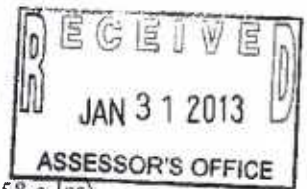
