## **DESCRIPTION OF REQUEST:** (state briefly why legislative action is requested)

The Department of Mental Health requests permission to enter into a contract in 2025 with Mental Health Empowerment Project (MHEP) for the provision of Mentally III Chemical Abusing (MICA) Homeless peer advocacy and support to Albany County citizens suffering from mental illness. NYS Office of Mental Health (OMH) will provide pass through funding to MHEP through Albany County Department of Mental Health for \$134,910. This appropriation is anticipated in the 2025 budget.
