This is a request for legislative action to amend the 2023 Stormwater Coalition budget, as follows:

Increase Enhanced Pay line (8021 19954) by \$3,750.00 Decrease GIS Specialist line (8021 12633) by \$3,750.00

Pursuant to voted upon items from a previously held Stormwater Coalition Board meeting, legislative authorization is requested in order to reallocate budgeted funds.

The Coalition has successfully hired a new Coalition Program Coordinator and as such, the Board has voted to enable a time period for cross training in which the previous Coordinator will work alongside the hired incumbent with the goal of ensuring unhampered operational continuance. Approval of this budget amendment will allow compensation parity among the two staff members of the Coalition.
