The Department of Public Works is requesting the Legislature's approval to enter into a contract with Tracey Road Equipment, Inc., for the purchase of one (1) Hyundai HL940A Wheel Loader using Sourcewell Contract #032119 HCE.

The purchase is part of the department's Vehicle and Truck Replacement Capital Plan Project. This Wheel Loader will be for our Westerlo Division. It is used during our snow removal season to load salt/sand and to push back snow on County and State Roads. This equipment is also used for the remainder of the year for loading materials and grading roadways. Bond money will be used in an amount not to exceed \$173,928.50.
