### **<u>DESCRIPTION OF REQUEST:</u>** (state briefly why legislative action is requested)

Approval is requested to renew a contract with the Montgomery County Chapter NYSARC, Inc. - DBA Liberty ARC (previously Schenectady County Chapter NYSARC, Inc. - DBA Pine Ridge Industries) to provide employment success coaching and related services for recipients of Temporary Assistance (TA) to maintain employment in the amount of \$100,000. An additional \$5,000 is requested for translation services, as needed.

Liberty ARC and its Career & Employment Network (CEN) is the exclusive operator of the Capital Region Employer Resource Network (ERN), one of 25 such programs across the United States designed to support employees and improve workforce retention in the Capital Region of New York. The program helps local businesses retain engaged and skilled workers while reducing turnover costs, creating a better workplace culture, and improving performance by deploying Success Coaches to member businesses.
