**Justification**: (state briefly why legislative action is requested)

The Department for Aging (DFA) requests legislative approval to enter into a contract with Life Path, to provide Social Adult Day Services to eligible older adults within Albany County. Life Path will provide access to social adult day services to the highest quality, enabling older adults to maintain an independent lifestyle for a long as possible. The Contractor will provide 12,675 hours of adult day services at their two locations.

Life Path provides day care services that include structured, comprehensive programing that provides functionally - impaired older adults with components including socialization, supervision, monitoring, personal care and nutrition, provided in a protective setting during the day, less than 24-hour period.
