### **<u>DESCRIPTION OF REQUEST:</u>** (state briefly why legislative action is requested)

Authorization is requested to contract with the Capital Area Council of Churches to provide mandated emergency Code Blue shelter services for Albany County homeless persons who are not eligible for contracted shelter or when contracted shelters are full.

This Seasonal Shelter serves chronically homeless men 18 years and older who are without other shelter options to provide protection from the elements. This homeless population often suffers from mental illness or addiction and is unable or unwilling to stay in more traditional shelters or hotel/motels. The shelter serves Albany County residents who live on the street and under bridges, primarily in the City of Albany. For many, this shelter is the only open door available.

The Shelter proposes serving 19 guests per night in a congregate setting between November 1<sup>st</sup> - April 30<sup>th</sup>. The Shelter offers a meal for guests each night and provides support and supervision for its guests while at shelter.

The Shelter doors open at 7:00 p.m. and guests depart the next morning at approximately 7:00 a.m. On extreme weather days (Code Blue), the Shelter opens at 5:00 p.m.

Between 11/1/23 - 4/30/2024, the Shelter recorded a total of 205 stays.
