Dear Chairman Joyce:

The attached correspondence is forwarded for presentation to the Albany County Legislature.

Legislative approval is required in order to allow the Albany County Sheriff's Office to enter into a contract with the New York State Division of Homeland Security and Emergency Services, Office of Interoperable and Emergency Communications. This will be to accept and spend funds from the attached 2023 Public Safety Answering Points (PSAP) Operations Grant Program award. This reoccurring grant was previously authorized under RLA 22-34, a copy of which is attached hereto.

The current award amount for Albany County is \$235,855.00. There are no matching funds associated with this grant.

The term of this contract will be 12 months from 1/1/23 to 12/31/23. As the award letter was just received 10/24/23 and the term ends 12/31/23, an extension for this grant will be requested and Legislative approval sought in the future to accept said extension once granted by NYS DHSES.

These funds will assist with the costs involved in maintaining our multi-jurisdictional PSAP operating expenses (such as network connectivity, software licensing, etc.).

I am pleased to announce that Albany County has been awarded \$235,855 under the New York State 2023 Public Safety Answering Point Operations Grant Program (2023 PSAP Grant). This program, administered by my agency, allows for State support to counties for eligible public safety call-taking and dispatching expenses. Your participation in this program is another example of the successful partnerships we have been developing for public safety and emergency preparedness across the state.

The performance period for the 2023 PSAP grant will be 12 months, beginning calendar year 2023 (January 1, 2023 – December 31, 2023). Expenses that you wish to claim must occur within that period. In order to provide these funds to you as quickly as possible, we will need to gather budget information within 30 calendar days of the date of this letter that reflects the award amount. WHEREAS, The Albany County Sheriff has requested authorization to submit a grant application to the New York State Division of Homeland Security and Emergency Services, Office of Interoperable and Emergency Communications regarding the Public Safety Answering Points Operations Grant Program for the term commencing January 1, 2022 and ending December 31, 2022, and

WHEREAS, The Sheriff has indicated that this funding will be used to assist with the costs involved in maintaining Albany County's multi-jurisdictional Public Safety Answering Points Operations, now, therefore, be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to submit a grant application to the New York State Division of Homeland Security and Emergency Services, Office of Interoperable and Emergency Communications regarding the Public Safety Answering Points Operations Grant Program for the term commencing January 1, 2022 and ending December 31, 2022, and, be it further

RESOLVED, That the County Attorney is authorized to approve said application as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.
