Saratoga Eagle is a new suite tenant of Suite #19 and they were next in line on the waiting list to lease a suite. The term of this lease will be from September 1, 2022 through August 31, 2025. The suite was previously leased by NYSCOBA. However, when Bank of America gave us notice that they would not be renewing their Suite #12, we went to the list of suite holders that are desirous to move to a better location and NYSCOBA was first on that list. Therefore, effective as of September 1, 2022, NYSCOBA moved to Suite #12 and their Suite #19 is being provided to Saratoga Eagle. A deposit in the amount of \$3,000 was paid from Saratoga Eagle and it will be applied towards suite payment owed in year #1.
