The county sponsors the annual Grant-in-Aid application, which supports multiple snowmobile club's efforts to maintain over 22 miles of trails in Albany County. This program awarded the county \$14,955 for the 2022-2023 season. We will be notified of this year's funding amount in the fall as it is determined by a percentage of revenue the state receives from permits. This is a pass-through grant to the trail maintenance organizations. There is no cost to the county and minimal clerical/administrative responsibility.
