I am pleased to announce that Albany County has been awarded \$62,646 in federal funding under the FY2024 Hazardous Materials (HazMat) Targeted Grant Program. Funding for this initiative is provided by the U.S. Department of Homeland Security's State Homeland Security Grant Program (SHSP) and is administered by the New York State Division of Homeland Security and Emergency Services (DHSES). The performance period for this award is April 1, 2026, through August 31, 2027.

As outlined in your application, this funding is provided for local emergency response teams that provide HazMat services through equipment, training, exercise, and planning projects.

Additionally, all capabilities developed through federal FY2024 SHSP funding are required to be deployable regionally and nationally per the federal guidelines. All funding through this grant program is subject to both New York State and federal guidelines and regulations. Finally, all training that is funded through this grant program must be submitted to DHSES within six (6) months of the date of this letter for review and approval.

WHEREAS, The Albany County Sheriff has requested authorization to submit a grant application to and enter into an agreement with the New York State Division of Homeland Security and Emergency Services regarding the fiscal year 2022 Hazardous Materials (HazMat) Grant in an amount of \$171,750 for a term commencing April 1, 2024 and ending August 31, 2025, and

WHEREAS, The Sheriff has indicated that the Sheriff's Office will act as fiduciary to provide the HazMat teams in Albany, Rensselaer, Saratoga, and Schenectady Counties with funding for training, equipment acquisition, equipment calibration and maintenance costs, and

WHEREAS, The Sheriff has also requested a budget amendment to incorporate the 2022 HazMat Grant funding into the 2024 Sheriff's Office Budget, now, therefore, be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into an agreement with the New York State Division of Homeland Security and Emergency Services regarding the fiscal year 2022 Hazardous Materials Grant in an amount of \$171,750 for a term commencing April 1, 2024 and ending August 31, 2025, and, be it further

RESOLVED, That the 2024 Sheriff's Office Budget is amended as follows:

Increase Revenue Account A3110 0 3306 Homeland Security by \$171,750

Increase Appropriation Account A3110.2 by \$100,000 by increasing Line Item A3110 2 2750 Security Equipment by \$100,000

Increase Appropriation Account A3110.4 by \$71,750 by increasing Line Item A3110 4 4046 Fees for Services by \$71,750

and, be it further

RESOLVED, That the County Attorney is authorized to approve said grant application and agreement as to form and content, and, be it further

RESOLVED, That the Clerk of the County Legislature is directed to forward certified copies of this resolution to the appropriate County Officials.


