DESCRIPTION OF REQUEST: (state briefly why legislative action is requested)

The Department for Aging (DFA) requests legislative authorization to amend the contract with Senior Projects of Ravena, to provide additional Congregate Meal Services to older adults who reside within Albany County and meet specific criteria as required by Albany County and New York State Office for Aging. Senior Projects of Ravena shall be responsible for ensuring meals meet nutritional requirements established by the Food and Nutrition Board of the National Academy of Sciences National Research Council. Senior Projects of Ravena will provide Congregate Meal Services to seniors at the following five (5) locations, Senior Projects of Ravena, Civill Apartments, Van Allen Apartments, Townsend Park, and Parkview Apartments.
