Properties are withdrawn from tax foreclosure as there exists a significant risk that the County of Albany might be exposed to a liability substantially in excess of the amount that could be recovered by foreclosing the tax lien. Pursuant to ABL resolution No 29 of 2019 the Albany County Disposition Plan, properties "withdrawn" from a foreclosure proceeding can be offered for sale through a sealed bid process with the sale price criteria being "an amount which reflects the benefit to the community stemming from the proposed use of the property. In this regard the Department of Management and Budget through the county website offered properties online through a sealed bid process which was conducted from September 14th until October 14th, 2022.

Authorization is requested to convey property located in the City of Albany, 89 Second Avenue, Tax Map No. 76.64-5-53 to Helen Opuana, 89 Lincoln Avenue, Saratoga Springs, NY 12866 for \$6,200.00. Helen Opuana was the sole bidder on this property and her submission indicates a detailed plan to rehabilitate this tax delinquent property which intern will benefit the community.

Helen Opuana has deposited the full amount of the bid offered \$6,200.00 by certified funds with the Albany County Division of Finance.

Helen Opuana is not required to have a review of property as she does not own any.

The following shall be the responsibility of Helen Opuana and is requested to be stated in the resolution: All closing costs.

All real estate taxes (Property or School), water and sewer bills, municipal charges or fees not in the collection process of the Albany County Division of Finance at the date of closing are the responsibility of Helen Opuana to pay.
