<u>Justification</u>: (state briefly why legislative action is requested)

With the COVID Act moratorium on foreclosures coming to an end, the Division of Finance finds itself in a position to need to ramp up the processing of a backlog of more than 2 years of foreclosures. This Budget Amendment seeks to increase the pay of the existing Foreclosure Clerk title (to attract candidates), retitle the Abstractor position as Title Searcher and create a second Title Searcher line to be able to complete this work.

Additionally, this Budget Amendment addresses a pay equity situation in the Division's mid-management level. The Amendment brings 3 titles to the same salary of 70,000.

This Budget Amendment is budget neutral for 2022.
