

RESOLUTION NO. 233

AUTHORIZING AN AGREEMENT WITH K5 CORPORATION REGARDING PAINTING TRAFFIC LINES ON ALBANY COUNTY ROADWAYS AND AMENDING THE 2022 DEPARTMENT OF PUBLIC WORKS BUDGET

By Public Works Committee:

WHEREAS, The Commissioner of the Department of Public Works has requested authorization to enter into an agreement with K5 Corporation as the sole bidder regarding Painting Traffic Lines on Albany County Roadways in an amount not to exceed \$320,813, for a term commencing July 1, 2022 and ending June 30, 2023, and

WHEREAS, The Department of Public Works through the County Purchasing Agent issued a request for bids and only one bid was received for Painting Traffic Lines on Albany County Roadways, and

WHEREAS, The Commissioner has also indicated that a budget amendment in the amount of \$116,104 is necessary to cover the cost of the agreement, now, therefore, be it

RESOLVED, By the Albany County Legislature that the County Executive is authorized to enter into an agreement with K5 Corporation, Rockland, MA 02370, regarding Painting Traffic Lines on Albany County Roadways in an amount not to exceed \$320,813, for a term commencing July 1, 2022 and ending June 30, 2023, with two additional one-year options to renew, at the following rates:
