General Services is requesting authorization for a contract with MJG Construction Group, LLC for the Stedman House Exterior Renovation Project with a not to exceed cost of \$831,500.00. The not to exceed cost includes their base bid of \$710,000.00, 15% contingency allowance of \$106.500.00 and a security access control system allowance of \$15,000.00.

This project will address exterior structural deterioration and historical preservation of the Stedman House building located at 1 Lodge Street adjacent to the Judicial Center.

Costs of this project will be covered by bond HHX0 Res. No. 10 of 2023.
