## **Justification**: (state briefly why legislative action is requested)

The three-year time limit to use the ordinary correction of errors process has expired, therefore, enclosed for your review is a resolution. In reviewing the 2015 List of Delinquent Taxes, it became apparent that a property tax bill was imposed on a tax exempt industrial development agency property in error. Parcel number 76.66-1-18, in the City of Albany is a property is owned by the City of Albany Industrial Development Agency. Pursuant to RPTL 412-a the property is statutorily exempt from taxation as a matter of law.

Given the information provided, I am requesting that the County Legislature adopt a resolution canceling the unenforceable property tax lien on 15 Rensselaer Street. Additionally, I am requesting that said resolution authorize a chargeback of all amounts credited or guaranteed to the City of Albany. The total amount of the chargeback is \$1,341.38.
