**ELECTRIC AND NATURAL GAS  
PROGRAM AGREEMENTS THROUGH OCTOBER 2029  
ENDORSEMENT**

Dear MEGA Participant,

MEGA is pleased to inform you that the program agreements for the electricity and natural gas supplies have been extended through October 31, 2029 as authorized by mutual agreement by MEGA, Genesee County, Constellation Energy, and NRG through a new public procurement awarded in 2024. MEGA's energy procurement program is available in the following utility territories: National Grid, New York State Electric & Gas, Central Hudson Gas & Electric, Rochester Gas & Electric, and National Fuel Gas until 2026, and from 2026 through 2029 in these territories plus Orange & Rockland Utilities, PSE&G – Long Island, and Con Edison.

**Electric, Natural Gas Supply, and RECs Bid Award--"Piggybacking" authorized**

MEGA's procurement for electric and natural gas supplies, and renewable energy credits, was conducted through Genesee County in conformance with New York State General Municipal Law and County Law. The Invitation to Bid was issued in November 2023, and bids were received on January 23, 2024. As MEGA has in the past, we have recommended the lowest qualified bidder be awarded the contracts by Genesee County. Our partner in this procurement, Genesee County, was in conformance with the "piggybacking" provisions of Section 408-a of the NYS County Law and Section 103(3) of the NYS General Municipal Law, allowing all political subdivisions and districts within the State of New York to participate in the contracts awarded as a result of this procurement.

We are pleased to give our endorsements as follows:

- To **Constellation Energy, Inc.** for all electricity supply program in the National Grid, New York State Electric & Gas, Central Hudson Gas & Electric, Rochester Gas & Electric utility territories through October 31, 2029, and for these territories plus Orange & Rockland Utilities, PSE&G – Long Island, and Con Edison from November 1, 2026 through October 31, 2029.
- To **NRG** for natural gas supply programs in the National Grid, New York State Electric & Gas, Rochester Gas & Electric, National Fuel Gas, and Central Hudson Gas & Electric utility territories through October 31, 2029, and these territories

plus Orange & Rockland Utilities, PSE&G – Long Island, and Con Edison from November 1, 2026 through October 31, 2029.
