Arcadis was the lowest responsible bidder of the three bids received. The District was already awarded a \$50,000 Engineering Planning Grant (EPG) from Environmental Facilities Corporation (EFC) that will be issued upon submission and approval of an engineering report outlining the findings of the study. With the inclusion of the \$50,000 EPG, the District's anticipated cost for this study is \$150,000.
